**Notification**

G.S.R.....(E).- In exercise of the powers conferred by clauses (b) and (c) of sub-section (2) of section 28 of the Brahmaputra Board Act, 1980 (46 of 1980) and in modification to the Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation, Brahmaputra Board (Chairman, Vice-Chairman and Financial Adviser) Group 'A' Posts Recruitment Rules, 2019, except as respects things done or omitted to be done before such modification, the Central Government hereby makes the following rules regulating the method of recruitment to the posts of Financial Adviser in the Brahmaputra Board, namely :-

1. Short title and commencement. - (1) These rules may be called the Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation, Brahmaputra Board (Financial Adviser) Group 'A' Posts Recruitment Rules, 2021.  
  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. Application. - These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
3. Number of posts, classification and level in pay matrix.- The number of the said posts, their classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the said schedule.
4. Method of recruitment, age-limit and qualifications, etc. - The method of recruitment, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the aforesaid Schedule.
5. Disqualification.- No person,-
  - (a) who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax. – Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
7. Saving. - Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Schedule Castes, the Scheduled Tribes, Other Backward Classes, ex-servicemen and other special categories or persons in accordance with the orders issued by the Central Government from time to time in this regard.
